The facility in Canada focuses on smaller bespoke products and limited production runs. It produces skincare products and body products and high-quality sanitizer products that are used in medical and non-medical applications. The facility has Canada NHP certification and FDA OTC certification for SPF products. This facility can produce natural SPF products along with the US facility which works with more traditional mineral and chemical formulas.

The facility in Italy has a long heritage in natural color products and has a long history of working with EU brands in developing and creating natural formulas for most color products except nail products and pencils. This plant is COSMOS and Ecocert certified as well as many of the other EU certifications. We also do some skincare manufacturing in this facility for smaller brands. The R&D talent in this facility is quite deep and capable of handling some of the most complicated natural products, especially those requiring natural formulas to be developed and manufactured here.

#### MOQs

Powder Minimums are a 5,000 unit with 1,000 units per shade. Liquid Color Cosmetics are a 5,000 unit minimum with 1,000 units per shade. Skincare, Hair care, personal care and deodorant formulas are 5,000 minimum. We can manufacture several products in the color cosmetics, skin care, haircare, and personal care categories. We can do runs as large as 250,000 per order. We can work with your existing formulas or create new ones. For new formulas, there is a development fee of US\$ 5,000 of which US\$ 3,000 is credited against your first order/PO. We do color matching and provide 3 revisions per formula after which there is a fee of US\$ 500 for additional revisions. Payment terms are 50% at the time of order placement and the balance due at shipment. We do lots of custom and natural and organic COSMOS / Ecocert formulas that comply with EU regulations as well as US regulations.

We have over 20 years of experience with natural materials as well as natural stabilization and preservation technologies. We can produce bulk orders as well as custom finished orders with components and packaging ready for sale to consumers. We can provide the required documentation for product registration in the EU market, US, or in other jurisdictions around the world.
